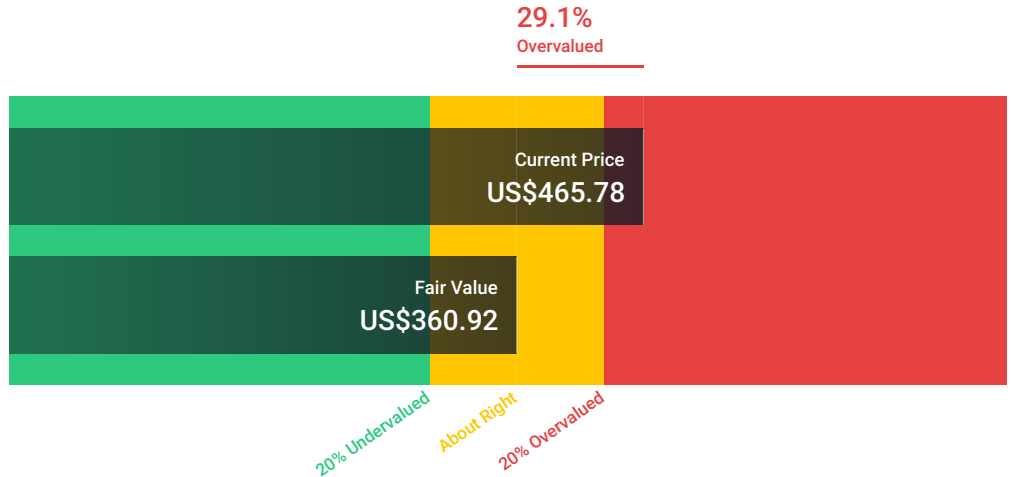

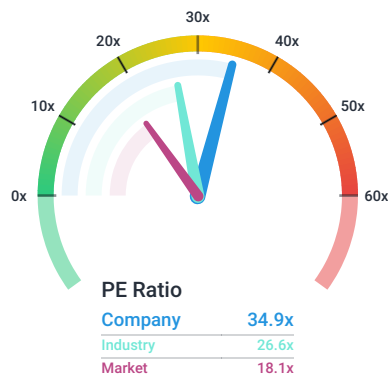

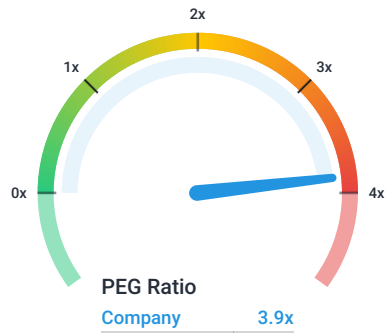

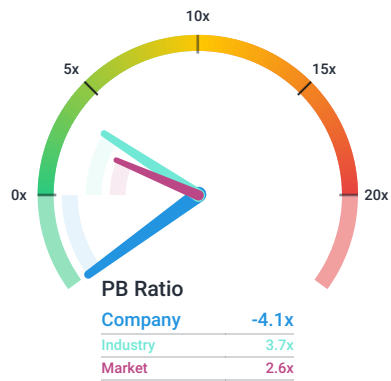

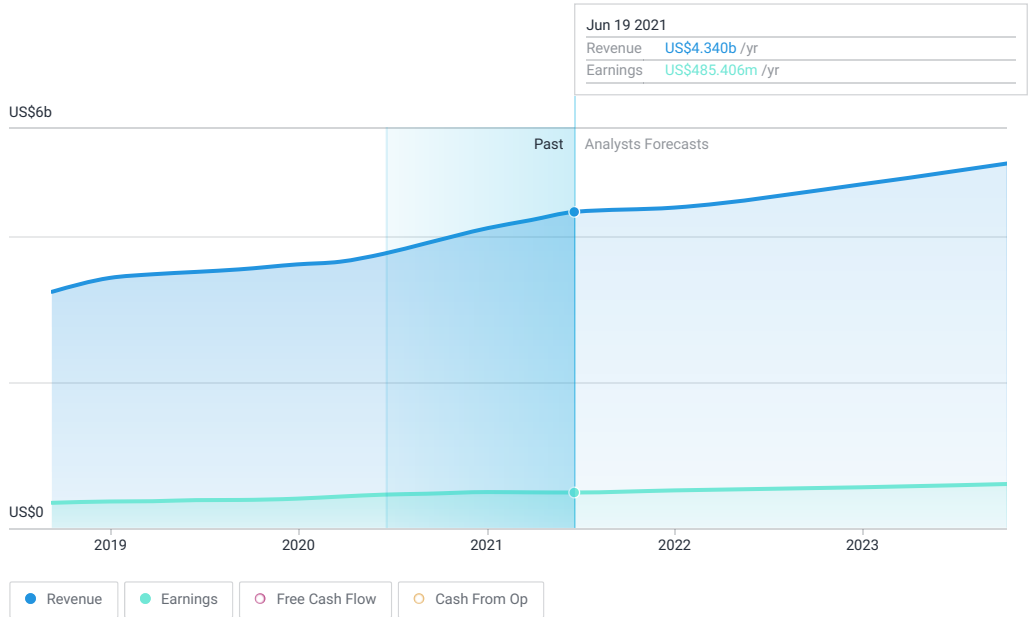

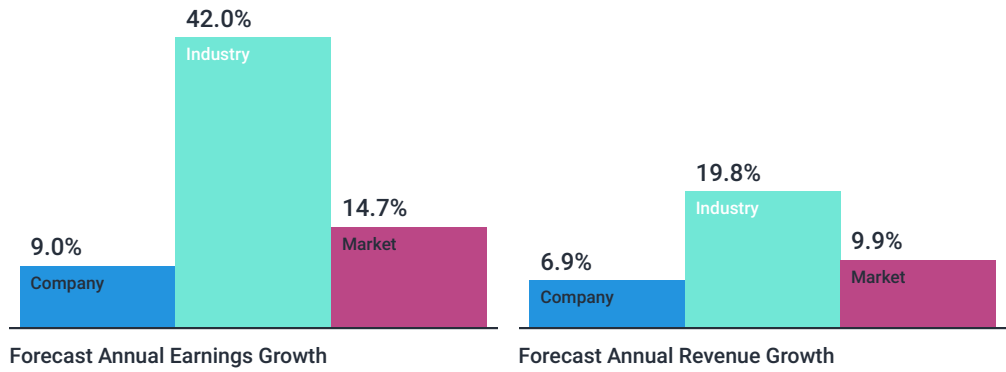

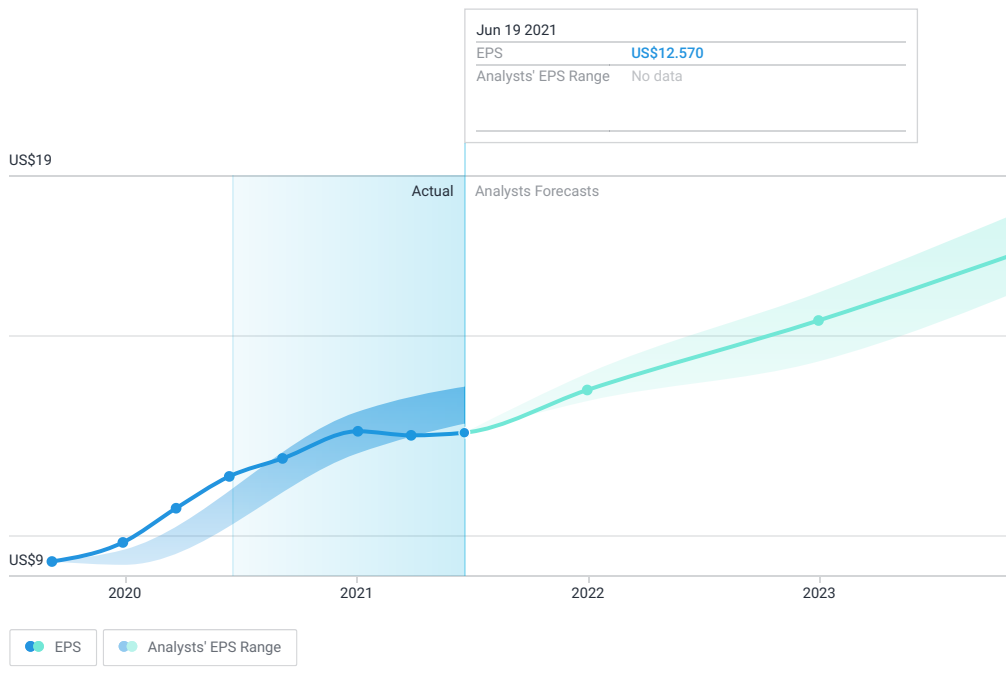

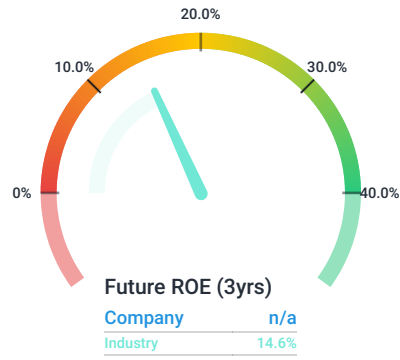



- ✔ **Earnings vs Savings Rate:** DPZ's forecast earnings growth (9% per year) is above the savings rate (2%).

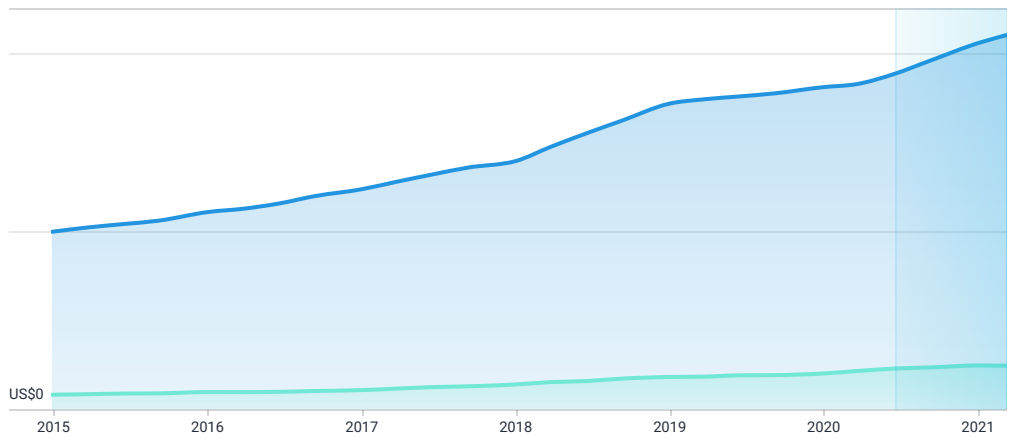

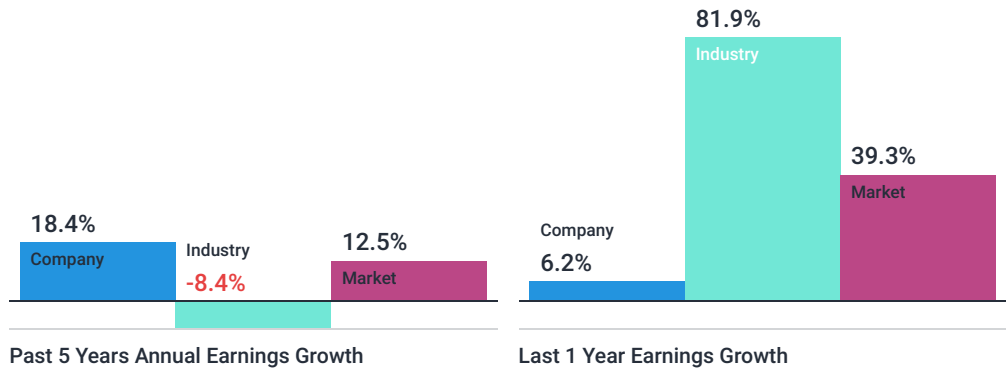

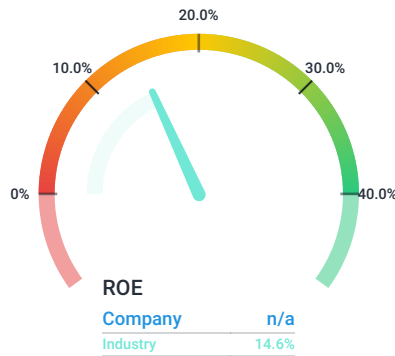

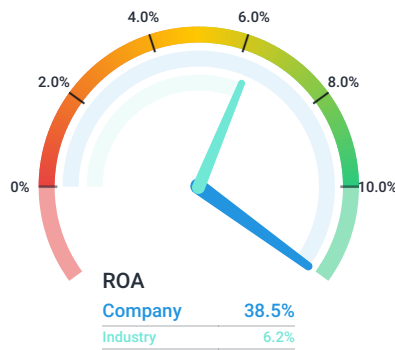

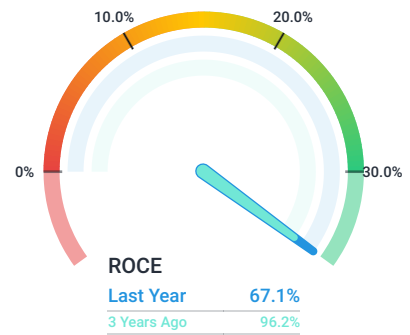

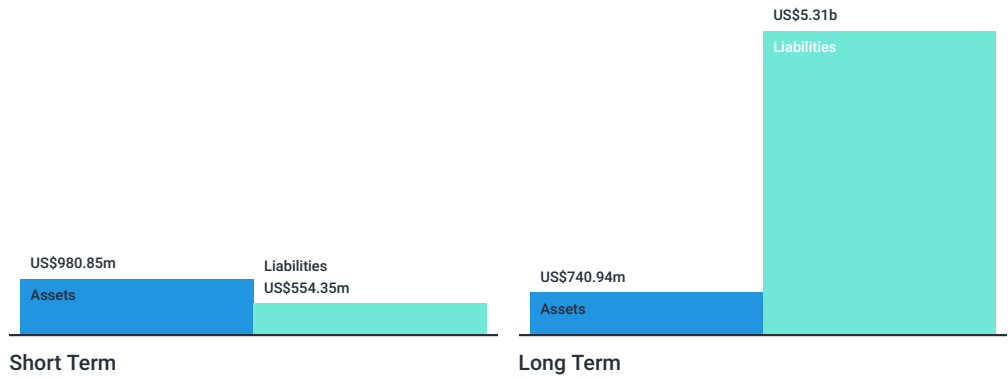

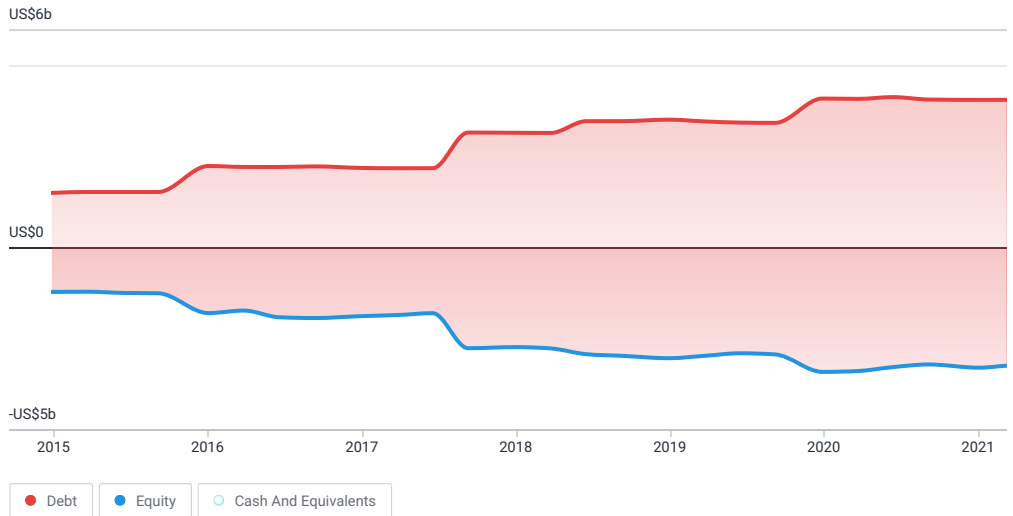

- ⊗ **Debt Level:** DPZ has negative shareholder equity, which is a more serious situation than a high debt level.
- ⊗ **Reducing Debt:** DPZ's has negative shareholder equity, so we do not need to check if its debt has reduced over time.
- ⊗ **Debt Coverage:** DPZ's debt is not well covered by operating cash flow (13.5%).
- ✓ **Interest Coverage:** DPZ's interest payments on its debt are well covered by EBIT (4.4x coverage).

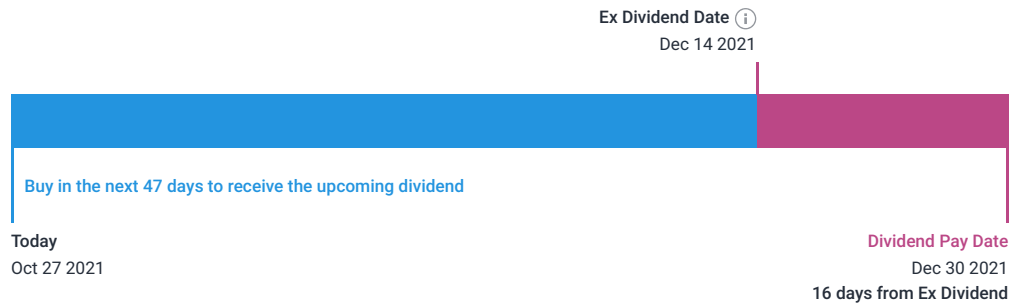

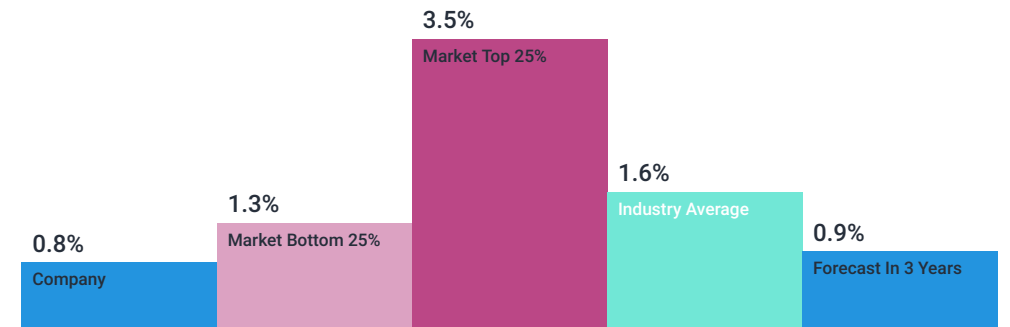

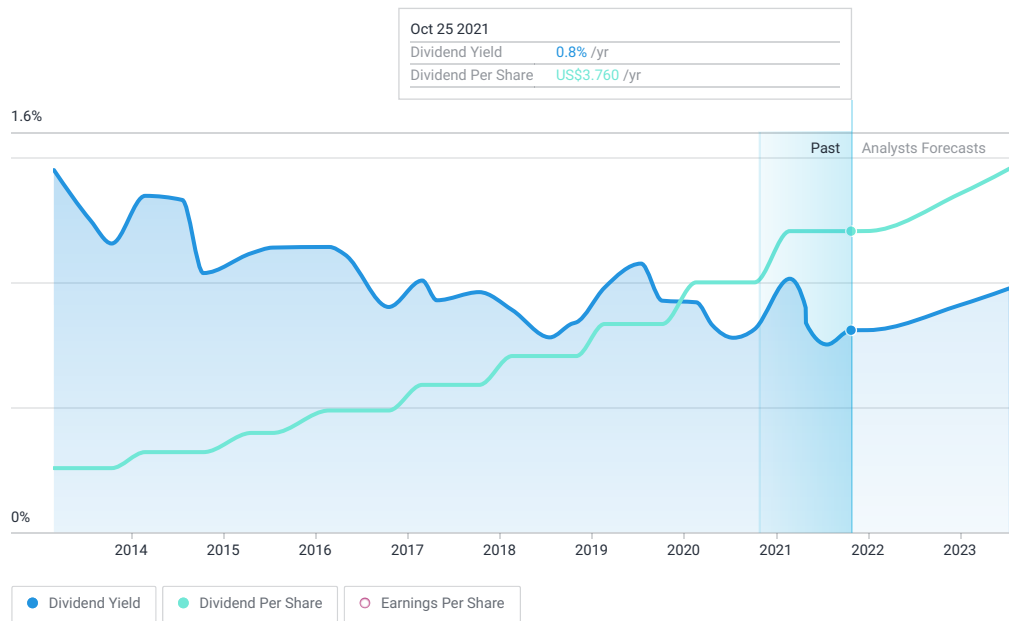


Current Dividend Yield Vs Market & Industry

⊗ **Notable Dividend:** DPZ's dividend (0.81%) isn't notable compared to the bottom 25% of dividend payers in the US market (1.27%).

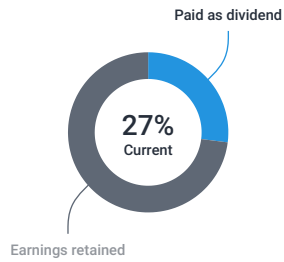

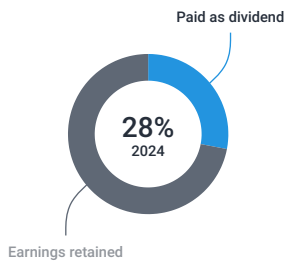

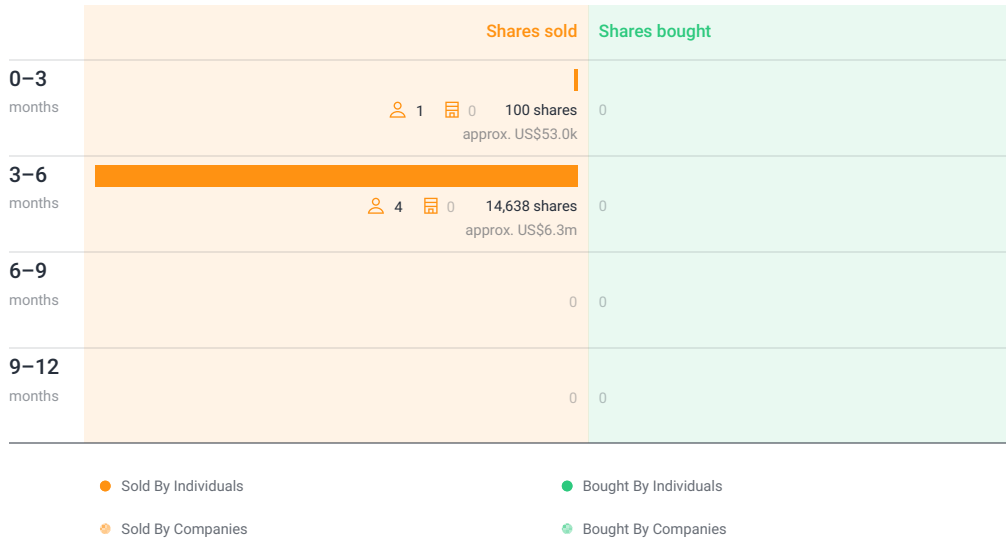
